

CHAIRMAN'S REPORT TO COLLEAGUES BILL SHARP

am very pleased to announce that your Federation has entered into an agreement with SDA Bocconi, the School of Management of Bocconi University in Milan (Italy), whereby Bocconi becomes a dedicated provider of instructional courses in technical analysis based upon the Body of Knowledge and course curriculum developed by IFTA. Such courses are designed to prepare students and professionals, who may wish to acquire accreditation, for examinations administered by our Federation. Students who successfully complete the two-level testing process will be awarded the designation of Certified Financial Technician. Those students who wish to be tested must become members of Societa Italiana di Analisi Tecnica, or another IFTA Society.

This partnership evolved largely due to the close cooperation and vision of Professors Allesandro Angeli at Bocconi and Henry (Hank) Pruden, IFTA's Roving Ambassador in Europe and the Middle East. The agreement also stipulates that IFTA will work together with the staff at Bocconi to facilitate their teaching efforts and enhance the design and quality of our examinations.



Bocconi's School of Management is considered to be the most important business schools in Italy, and one of the best in Europe. Last year it was the only institution on Italian soil recognized for executive education by the Financial Times, ranking 28th world-wide and 10th in Europe.

We expect that this non-exclusive, collaborative arrangement with Bocconi will serve as a model for developing relationships with other institutes of higher learning, especially in countries where IFTA Societies are established.

"C'est la vie," as the English would say....

I am writing with great sadness to inform you of the passing of our good friend and colleague Frank Vlug from the Netherlands at age 44, way too young. Many of you have known him as a very professional analyst and a dedicated IFTA board member who did an outstanding job putting together the conference manual, which has proven to be an excellent guide for conference organizers in years past.

Personally, I worked together with Frank at Robeco for more than five years, and recently we were again involved in various joint projects, One of them the revival of the Dutch Society of Technical Analysts.

Sometime in March Frank told me that he had been diagnosed with colon cancer. The good news, as he stated, was that it was in its early stages, and that the doctors were pretty confident that a relatively minor operation would be sufficient to remove and cure it. Shortly after this diagnosis he underwent the necessary surgery, and the initial results looked very good. According to the doctors it could not have gone better that day. However, some days after the operation complications started to arise, and the situation grew worse and worse by the week, eventually leading to three heart failures in about 6 weeks. The last one in the early hours of Sunday 8 May was too much for Frank....

We will remember Frank as a dedicated technical analyst and as somebody one could count on. No big stories, but simply delivering what he promised and always willing to help out a colleague.

On a personal note: I know that Frank was a very loving and caring husband and father for his family. He leaves behind his wife Loes and their two children Thomas (15) and Dominique (12). Let our thoughts and support be with them.

So long Frankie-boy! We will miss you!

IFTA FINANCIAL UPDATE (ACCOUNTS 2004)

I, Peter Pontikis, Treasurer of IFTA, on behalf of the Finance Committee, am pleased to present a summary of the Federation's financial affairs as at 31st December 2004 to our Member Societies and Colleagues.



The fiscal condition of the Federation at the end of December 2004 [and for the fiscal year 2004] was USD \$217,454.01. This represents an increase of 12.72% or a \$24540.96 increase above the corresponding amount at the end of the December year 2003. The committee had budgeted for an operating loss against the budget of \$500, compared to an operating loss of \$3116.14: thus the actual results were \$2616.14 below expectations.

The cheques written prior to 31st December 2004 and not cashed amounted to \$11,135.84 (and is included in the figure for accounts payables mentioned below).

The up to date cash balances as at 31st December 2004 continue to indicate a healthy financial position for the Federation. The Finance Committee sees no material item at this point to indicate otherwise with the information as at this day of sign off.

Please note: The adjustments mid way through the fiscal year 2004 to the DITA account classifications [to better reflect futures changes to the DITA scheme of delivery and arrangements] will continue to make pre and post change budget quarterly comparisons strictly not comparable.

The accounts were also prepared on an accruals basis, with accounts payable of \$14,052.01 for expenses incurred and pertaining to the year ended 31st December 2004. This is compared to accounts receivable for revenues of \$ 22,662.45for the same period, but not received.

Contact was first made between IFTA and the Chairman of *Asosiasi Analis Teknikal Indonesia*, Mr Mochammad Yusuf, in 1994. In the following years a number of informal meetings were held, but the "Asian Crisis" of 1997/98 disrupted the progression toward establishment of formal ties with IFTA. More recently, AATI has evolved into a vibrant TA society with some 400 people participating in their open-entry Yahoo Group - milis-AATI@yahoogroups.com

The *East African Technical Analysis Society* (EATAS) is based in Kampala, Uganda, but also represents the neighboring countries of Ethiopia, Kenya, Tanzania, Burundi and Rwanda on a non-exclusive basis. Groups within each of these additional countries remain free to submit an application for membership of IFTA once they meet the standard requirements. The President of EATAS is Mr Beenunula Nunumisa, who has broad knowledge of the field of international finance & investment, with experience in Europe, Asia and North America. We look forward to receiving news of future meetings and activities of EATAS.



Applications and expressions of interest have also been received from a number of societies from countries in the Middle East and Eastern Europe. The Membership Committee is working to help these groups move toward Developing Society status.

But you may know much of that already, so here are a couple bits of Vancouver history to make you want to attend the conference this November and experience this place for yourself.

16,000 to 11,000 BCE: Segments of the Coast Salish people-the ancestors of several Indian bankds still in the area today-arrived from Asia.

1592 - 1774 CE: The Spaniards cruised by as part of their exploration of Canada's west coast. Spain claimed the west coast of North America.

1792: Captain George Vancouver arrived. He spent one day here, just long enough to discover the Spanish had already claimed the place.

1827: Hudson's Bay Company built a trading post, the first permanent nonnative settlement in the Vancouver area. Since 1893 the company has occupied a prime location in Vancouver's downtown core and they're still trading.

1858: The news there was gold on the banks of the Fraser raised a bit of interest. About 25,000 prospectors dropped in to have a look.

1886: City of Vancouver incorporated; population about 1,000. On June 13 a brush fire burnt the city to the ground in less than 30 minutes. Rebuilding began.

1887: The Canadian Pacific Railway's first train arrived; the final stop of the first transcontinental trip.

1891: The city's first tram-based public transit system, the Interurban starts up.

1900: Vancouver surpasses the provincial capital of Victoria in size.

1911: Canada's first artificial ice rink, the Arena, opened. At the time it was the largest indoor ice rink in the world. e.

1915: The University of British Columbia opens for business. A few students showed up. There are 17,000 there now.
