The Alpha version of the on-line registration and exam management system proved to be overall successful. Research papers. In addition, future editions of the *IFTA Journal* will also contain a book review section on both new releases in TA and some of the classic literature.

The 2008 Journal was officially released at the start of the 20th IFTA Conference held in Sharm el Sheikh, Egypt. Here, the Egyptian Society of Technical Analysts hosted almost 200 delegates and speakers from all parts of the globe at the first conference held in the Middle East. This very successful conference, with engaging and stimulating speakers, gave delegates a special opportunity for global networking, learning and new impulses and ideas on TA. The success of a conference is not only measured by how many delegates attend, or the lineup of speakers. The lasting impact of a professional conference is a mark of success. And on this the 20th Annual Conference achieved high marks. There was enormous interest in the Conference—the local CNBC affiliate covered it in detail with reporting and interviews with speakers and delegates.

Conference speaker Tom Dorsey also reports on his impression of the 20<sup>th</sup> IFTA Conference in a highly popular podcast of November 14<sup>th</sup> (<http://www3.dorseywright.com/podcast.php>). Our host, ESTA, reports a greater awareness of the professionalism of TA and interest in the society.

Another impact of the Conference is impulses given to other societies in the region and beyond. In a recent report, Sheree Alsayed writes that after the conference the Jordanian Society of Technical Analysis (JTAS) received many inquiries on membership and education from individuals and institutions; and that as a result of the conference and contacts made, professional seminars will be organized in 2008. Sheree closes her report with the enthusiastic spirit:

*I've got my hands full , but I am happy and I feel we have just got started it is just the beginning , when we come to the conference next year and have our yearly review of what we've done I hope mine will have the most achievements.*

The 21<sup>st</sup> IFTA Conference will return to Paris, France and be hosted by the Association Française des Analystes Techniques (AFATE) under the Chairmanship of Julien Nebenzahl. Details of the conference will appear on the IFTA web site and elsewhere soon.

The day preceding the Annual Conference the IFTA Board of Directors holds its annual meeting. One of the key themes arising from the meeting was that because IFTA is a growing organization, many of the procedures that have developed over the years need to be formalized and standardized to meet the needs of our

membership. As a result of this, members will see, for example, initiatives to revise the IFTA Code of Ethics, an introduction of a standardized form for collecting operational data from members, and the open soliciting of conference bids two years ahead.

In addition, two important motions that were passed are to 1) pay \$50.00 per candidate to all societies sending candidates to an IFTA examination, but not wishing to take on local administration and proctoring in exchange for \$150.00 per candidate; and 2) have the Accreditation Committee define criteria for IFTA member societies to take on local exam management. Detailed information on these motions will be sent to all member Liaisons in the next weeks.

Another development members will see in 2008 is that we will greatly miss our Administrator and Business Manager Ilse Mozga. I first met Ilse in 2003 at the IFTA conference held in Washington, D.C. I was struck by her interest in our organization and commitment to the unknown tasks ahead. She quickly learned the IFTA ropes (no easy task!) and immediately introduced professional procedures with a high level of responsiveness to all members and colleagues. Her work and professional dedication to IFTA was a major contribution to the growth and success we now face.

As a result of the new and growing challenges facing IFTA, the Board overwhelmingly voted to move to full time professional association management starting in January 2008 with Management Solutions Plus, Inc. MSP, located in Rockville, Maryland, is a full service professional Association Management Company specializing in ongoing management of non-profit and charity organizations. In the next weeks, our members and colleagues will be introduced to Karen Hutchison who will serve as the Executive Director of IFTA.

We have busy months ahead of us, and I look forward to seeing many of our colleagues next fall in Paris.



## TREASURER'S REPORT "further to the accounts as at Nov. 30, 2007"



I, Peter Pontiks, Treasurer of IFTA, on behalf of the Finance Committee, am pleased to present a summary of the federation's financial affairs as at 30<sup>th</sup> November 2007 to our Societies and Colleagues.

The fiscal condition of the Federation remains healthy, with liquid assets at 30<sup>th</sup> November 2007 of USD \$361,093.04. This represents an increase of 25.1% or an increase of \$72,484.98 above the corresponding amount at the end of the fiscal year 2006. The committee reports that the year to date (cash basis) operating profit as being \$95,547.64, as against the provisional budget for a profit of \$2250.00.

There are likely to be at least two substantial expenses expected (though not yet sighted) into the end of the year to be estimated in the region of US\$ 30,000.00 due to the STA for CFTe examination services throughout 2007, and another \$10,000 approximately in board meeting expenses. This will substantially reduce the likely accrual profit for the 2007 year to a figure nearer the budgeted profit figure. Thus, on current indications, the budget expectations for the whole of 2007 are at least likely to be met.

The up to date cash balances overall at 30<sup>th</sup> of November 2007 continue to indicate a healthy financial position for the Federation where there is no material item at this point to indicate otherwise with the information as at this day of sign-off.


